Glass moved; Riley seconded to approve Resolution #2026-6 Burns Township 2026-27 General Appropriations Act as presented. With General Fund Revenues of \$669,550 which includes 1.0 mil and \$1,020,305 Expenses. Fire Operating Fund Revenues of \$178,500 which includes 1.0 mil and \$396,548 Expenses. Fire Equipment Fund Revenues \$133,400 which includes .75 mil and \$422,000 Expenses. Ambulance Fund Revenues \$236,040 which includes \$140 per unit Special Assessment and \$236,040 Expenses.
